

Q1 Should the council build a new \$60 m headquarters building?

It/They certainly have no track-record of achieving such an outcome with any recent significant project. Why is QLDC even thinking of signing up for this \$60million ego-Project, when we have leaking, under-specced sewage systems, clogged roads, unsafe water treatment plants, and massive debt commitments from Leaky Buildings settlements? The CBD of Queenstown is now very much about Tourists. 18% of the QLDC population lives in the vicinity of or adjacent to the CBD where Project Manawa is proposed to be located (Queenstown, Frankton Corridor, Fern Hill, Sunshine Bay, Closeburn, Glenorchy). 82% of the Council's constituents live closer to Frankton and/or Ladies Mile! A Service Organisation should surely locate itself for the convenience of the majority of its "Customers" (Constituents) - not force them through snarled-up traffic to where there is no parking, or where there a poor public transport options).
