
## Q1 Do you support the move by four QLDC councillors to review the sole charge of QLDC's CEO over the \$1 billion Lakeview project?

Simple. There is NO Ratepayer authority for Council Officers to arrange or agree non disclosure with commercial suppliers to eliminate Councilors from their elected role. The employee appointment is at the sole purpose of working for the collective Ratepayer body, these employees certainly have NO exclusive rights to reserve Ratepayer owned information to their own exclusivity. The role of Elected Mayor is that of policy co-ordination and leadership. The Mayor has no legal mandate to restrain Councilors from undertaking their elected obligations, nor is there any legal mandate for collusion with Employees, contractors or suppliers to that same effect. Does it take a Judicial Review to establish the Rights of Ratepayers and their elected Representatives. Individual Persons DO have a presumption of Innocence, but Corporate and Collective Bodies DO NOT. Corporate and Collective Bodies may be considered as working in self interest and even crony arrangements (following the ageless pattern of human nature).
